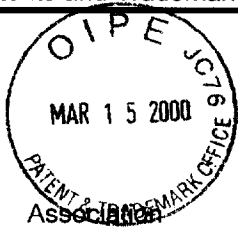

ASSIGNMENT

This Assignment is made the 6th day of December 1999

BETWEEN

1. 70s Limited, an English company, whose registered office is Langley House, Park Road, East Finchley, London N2 8EX (the "First Assignor")
 2. 70s Inc. a Panamanian corporation of P.O.Box 6-2875, El Dorado, Panama (hereinafter called the "Second Assignor")
- and
3. Columbia Pictures Industries, Inc., a Delaware Corporation of 10202 West Washington Boulevard, Astaire Building, Second Floor, Culver City, California, USA (hereinafter called "the Assignee")

WHEREAS

- A. The First Assignor is the registered proprietor of UK Trade Mark Registration No.2155914 and Community Trade Mark Application No.00058740 and the recorded Applicant in the matter of Japanese Trade Mark Application No.11-42672 and USA Trade Mark Application o.75/704852, particulars of which are set out in the Schedule hereto (hereinafter called "the First Trade Marks")
- B. By virtue of a Deed of Assignment dated 27 August 1998 the Second Assignor assigned to the first Assignor the beneficial ownership of the Cypriot Trade Mark Application Nos.48392, 48393 and 48394, Japanese Trade Mark Registration No.4310052 and USA Trade Mark Application No.75/378350, brief particulars of which are set out in a Schedule hereto (hereinafter called "the Second Trade Marks"), but the change of

ownership of the Second Trade Marks has not been recorded and the Second Assignor remains the recorded proprietor of the Second Trade Marks.

- C. The parties hereto have agreed that all rights in the First and Second Trade Marks should be assigned from the First and Second Assignors to the Assignee on the terms hereinafter appearing

NOW THEREFORE:

- (i) In consideration of the Assignee entering into the Confidential Settlement Agreement of even date, the First and Second Assignors hereby assign to the Assignee the First Trade Marks and the Second Trade Marks along with all rights relating to the First Trade Marks and the Second Trade Marks together with all common law rights associated therewith and the right to bring proceedings and secure all remedies in respect of any infringement of the First Trade Marks and the Second Trade Marks or passing-off of the First Trade Marks and the Second Trade Marks which may have occurred prior to the date hereof but without the entire goodwill of the business relating to the Goods and Services TO HOLD the same unto the Assignee absolutely
- (ii) The First and Second Assignors undertake to execute all such documents forms authorisations and depose to or swear a declaration or oath as may be required for vesting absolutely the full right title and interest in the First Trade Marks and the Second Trade Marks in favour of the Assignee
- (iii) This Assignment is governed by the laws of England and the Assignee and Assignor agree to submit to the exclusive jurisdiction of the High Court of England and Wales in respect of any matter or dispute arising hereunder or in connection herewith.
- (iv) It is hereby certified that the transaction hereby effected does not form part of a larger transaction or series of transactions in respect of which the amount or value or the aggregate amount or value of the consideration exceed £250,000
