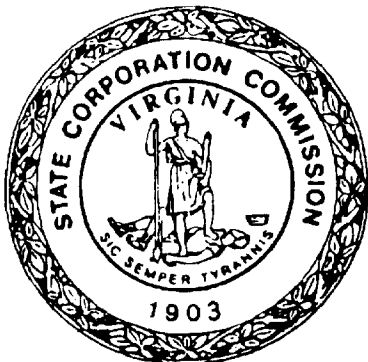

ARTICLES OF AMENDMENT

of

THE LIFE INSURANCE COMPANY OF VIRGINIA

1. The name of the corporation is THE LIFE INSURANCE COMPANY OF VIRGINIA.
2. The amendment hereby adopted to the Restated Articles of Incorporation by this Articles of Amendment, to be effective on January 1, 1999, is the deletion of the name:

The Life Insurance Company of Virginia

in Section 1 as the name and style of the Company and the substitution, in lieu thereof, of the name:

GE Life and Annuity Assurance Company

to be the name and style of the Company henceforth.

3. Effective on May 18, 1998, the Board of Directors found the amendment to be in the best interests of the corporation and directed that it be submitted to the corporation's two shareholders, General Electric Capital Assurance Company and GE Financial Assurance Holdings, Inc., for their approval.
4. 4,000 shares of Capital Stock, par value \$1,000 per share, are issued and outstanding and effective on May 18, 1998, the holders thereof, General Electric Capital Assurance Company and GE Financial Assurance Holdings, Inc., unanimously consented in writing to such amendment.
