

ASSIGNMENT OF NUPIPE TRADEMARKS

This Assignment of NuPipe Trademarks is effective as of the 31st day of March, 1999 from NuPipe, Inc., an Oregon corporation with its principal place of business at 702 Spirit 40 Park Drive, Chesterfield, Missouri 63005 and formerly at 1770 Kirby Parkway, Memphis, Tennessee 38138 and 3315 Democrat Road, Memphis, Tennessee 38118 (hereinafter referred to as "NuPipe"), to Insituform Technologies, Inc., a corporation organized under the laws of Delaware, having its principal office at 702 Spirit 40 Park Drive, Chesterfield, Missouri 63005 and formerly at 1770 Kirby Parkway, Memphis, Tennessee 38138 and 3315 Democrat Road, Memphis, Tennessee 38118 (hereinafter referred to as "ITI").

WHEREAS, NuPipe is a wholly owned subsidiary of ITI, and ITI and NuPipe are parties to a plan of merger of NuPipe into and with ITI whereby ITI is to become the owner of all of the assets of NuPipe effective March 31, 1999; and

WHEREAS, NuPipe has adopted and is using the NuPipe trademarks and is the record owner of the trademark and registrations identified in the annexed NUPIPE TRADEMARK SCHEDULE A and the parties are desirous of recording the transfer of all of the right, title and interest of NuPipe in, to and under the trademarks and United States registrations identified in the annexed NUPIPE TRADEMARK SCHEDULE A from NuPipe to ITI, such assignment being made simultaneously upon the merger of NuPipe into ITI; and

NOW, THEREFORE, in consideration of the mutual representations, warranties and covenants hereinafter set forth, and for other good and valuable consideration paid by ITI to NuPipe, the sufficiency and receipt of which is hereby acknowledged, the parties hereby agree as follows.


NuPipe by these presents does sell, assign and transfer to ITI, its successors and assignees, all right, title and interest in and to the trademark and service mark and NuPipe Registrations identified in the annexed NUPIPE TRADEMARK SCHEDULE A for NUPIPE together with that part of the goodwill of NuPipe's business connected with the use of and symbolized by the trademarks and including the right to sue for past infringements; and

NuPipe further authorizes and requests the official whose duty it is to record ownership of trademark and service mark registrations to record ownership of the trademark and service registrations identified in the annexed NUPIPE TRADEMARK SCHEDULE A as the property of ITI; and

NuPipe further covenants and agrees that it will communicate to ITI, its successors, legal representatives and assigns, any facts known to it respecting the improvements, and testify in any legal proceeding, sign all lawful papers, make all rightful oaths and generally do everything possible to aid ITI, its successors, legal representatives and assigns, to obtain and enforce proper trademark protection in all countries.


