

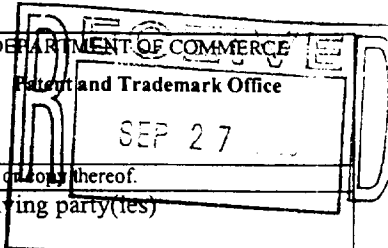

Pursuant to the provisions of Article 4.04 of the Texas Business Corporation Act, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE ONE

The name of the Corporation is HOWARD SCHULTZ & ASSOCIATES, INC.

ARTICLE TWO

The following Amendment to the Articles of Incorporation was adopted by the Shareholders of the Corporation on June 21, 1999. This amendment changes the name of the Corporation. ARTICLE FIVE






