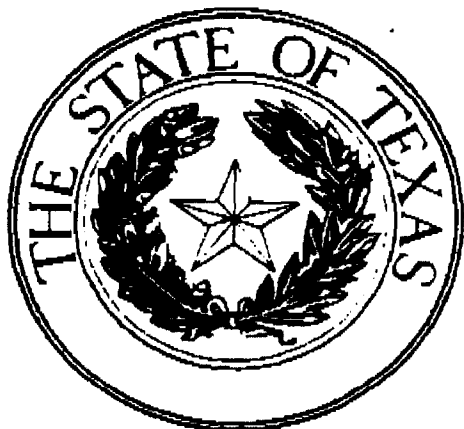

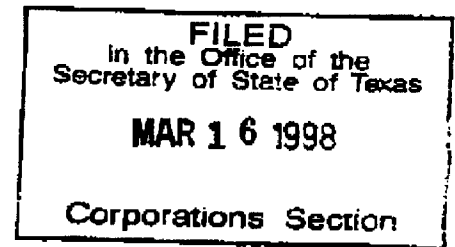

to the  
Articles of Incorporation  
of

Pursuant to the provisions of Article 4.04 of the Texas Business Corporation Act, the undersigned corporation adopts the following First Amendment to its Articles of Incorporation:

**ARTICLE I**

The name of the corporation is Texas-Advantage Properties, Inc.

**ARTICLE II**

The following amendment to the Articles of Incorporation was adopted by the sole shareholder of the corporation on March 4, 1998. The amendment alters or changes Article I of the original Articles of Incorporation in its entirety and the full text of Article I is amended as follows:

**"ARTICLE I.**

The name of the Corporation is Spectrum Apartment Locators, Inc."

**ARTICLE III**

The number of shares of the corporation outstanding at the time of such adoption was one thousand (1,000) shares of Common Stock; and the number of shares entitled to vote thereon was one thousand (1,000) shares of Common Stock.

**ARTICLE IV**

The sole shareholder of all of the shares outstanding and entitled to vote on said amendment has signed a consent in writing adopting said amendment.
