TRADEMARK SECURITY AGREEMENT

WHEREAS, Gibson Tube, Inc., a Delaware corporation ("Grantor") with its principal place of business at 100 Aspen Hill Road, North Branch, New Jersey 08876, owns the Trademarks, Trademark registrations, and Trademark applications listed on Schedule I annexed hereto, and is a party to the Trademark Licenses listed on Schedule I annexed hereto;

WHEREAS, Grantor, Rath Manufacturing Co., Inc., a Delaware corporation ("Rath"), ~~The Chase Manhattan Bank~~, as Administrative Agent (together with its successors and assigns, "Grantee"), Agent and Documentation Agent, Heller Financial, Inc., as Agent and Syndication Agent, and certain lenders ("Lenders"), are party to that certain Amended and Restated Credit Agreement dated as of February 3, 2000 (the same, as it may be amended, restated, supplemented or otherwise modified and in effect from time to time, the "Credit Agreement") providing for extensions of credit to be made to Grantor and Rath by Lenders; and

WHEREAS, pursuant to the terms of that certain Security Agreement dated as of February 3, 2000 (the same, as it may be amended, restated, supplemented or otherwise modified and in effect from time to time, the "Security Agreement"; terms used herein and not otherwise defined herein having the respective meanings provided for in the Security Agreement), between Grantor and Grantee, Grantor has granted to Grantee a security interest in substantially all the assets of Grantor, including all right, title and interest of Grantor in, to and under all now owned and hereafter acquired Trademarks, Trademark registrations, Trademark applications and Trademark Licenses, together with the goodwill of the business symbolized by Grantor's Trademarks, and all proceeds thereof, to secure the payment of the Secured Obligations;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantor does hereby grant to Grantee, for its benefit and the benefit of the Agents and the Lenders, a continuing security interest in all of Grantor's right, title and interest in, to and under the following (all of the following items or types of property being herein collectively referred to as the "Trademark Collateral"), whether presently existing or hereafter created or acquired:

- (1) each Trademark, Trademark registration and Trademark application, including, without limitation, the Trademarks, Trademark registrations (together with any reissues, continuations or extensions thereof) and Trademark applications referred to in Schedule I annexed hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark, Trademark registration and Trademark application;
- (2) each Trademark License, including, without limitation, each Trademark License listed on Schedule I annexed hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark License; and

- (3) all products and proceeds of the foregoing, including, without limitation, any claim by Grantor against third parties for past, present or future (a) infringement or dilution of any Trademark or Trademark registration including, without limitation, the Trademarks and Trademark registrations referred to in Schedule I annexed hereto, the Trademark registrations issued with respect to the Trademark applications referred to in Schedule I and the Trademarks licensed under any Trademark License, or (b) injury to the goodwill associated with any Trademark, Trademark registration or Trademark licensed under any Trademark License.

This security interest is granted in conjunction with the security interests granted and reaffirmed to Grantee pursuant to the Security Agreement. Grantor hereby acknowledges and affirms that the rights and remedies of Grantee with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.


