ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
DF FLORAL, INC.

I.

The name of the corporation is DF Floral, Inc. (the "Corporation").

II.

Article I (Name) of the Articles of Incorporation of the Corporation is hereby amended to read in its entirety as follows:

"ARTICLE I. NAME

The name of the corporation is Field of Flowers, Inc. (hereinafter called the "Corporation")."

III.

This Amendment was adopted pursuant to Sections 607.0821 and 607.0704 of the Florida Business Corporation Act by written consent of the sole member of the board of directors and by the holder of a majority of the outstanding shares of capital stock of the Corporation on January 10th, 1994. The number of votes cast for the amendment was sufficient for approval by the shareholders.
