



## ASSIGNMENT OF PROPRIETARY RIGHTS

THIS ASSIGNMENT OF PROPRIETARY RIGHTS ("ASSIGNMENT"), made as of this 7<sup>th</sup> day of April, 2000, is by and among General Polymers Corporation, General Polymers West, Inc. and General Polymers International, Inc. (individually, an "Assignor" and collectively, the "Assignors") and The Sherwin-Williams Company (the "Assignee").

### WITNESSETH:

WHEREAS, Assignors, Assignee, R. Thomas Davidson, Jeffrey K. Heinichen and John D. Durig have entered into a Purchase Agreement, dated April 7, 2000 ("Agreement"); and

WHEREAS, Assignors are the sole and exclusive owner of all right, title and interest in and to all names (including but not limited to "General Polymers"), patents, patent applications, inventions, marks, formulas (patented and unpatented), symbols, trade names, trademarks, service marks, trade secrets, technical know-how, methods, operations, copyrights, copyright applications, logos, franchises, software, processes (patented and unpatented), process instructions, permits, licenses and sublicenses (and agreements in respect thereof or applications therefor), patent, trademark and copyright prosecution histories, laboratory notebooks and all other proprietary rights, documents, information and records including, but not limited to, all filings, registrations or issuances of any of the foregoing with or by any federal, state, local or foreign regulatory, administrative or governmental office or offices, and all federal, state and common law rights protecting such in the United States of America and throughout the world related to the Business (as defined in the Agreement) including, but not limited to, those listed on Schedule A, which is attached hereto and made a part hereof ("Proprietary Rights"); and

WHEREAS, Assignee desires to acquire ownership of the Proprietary Rights and each Assignor is willing to convey to Assignee all of its entire right, title and interest in and to the Proprietary Rights; and

NOW, THEREFORE, for the consideration recited in the Agreement and the premises, agreements, covenants and provisions contained herein, as well as other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignors and Assignee hereby agree as follows:

1. Each Assignor hereby sells, assigns, transfers and delivers to Assignee its entire right, title and interest in and to the Proprietary Rights.
2. Upon Assignee's request, each Assignor will execute any and all instruments necessary to effectuate the intent of Section 1 hereof in order to confirm and secure the assignment of each Assignor's entire right, title and interest in and to the Proprietary Rights.
3. Upon Assignee's request, each Assignor shall transfer to Assignee all existing documents and files available to or in its possession which relate to the Proprietary Rights.



ACCEPTANCE OF ASSIGNMENT

In consideration of the foregoing Assignment of Proprietary Rights, Assignee hereby accepts from each Assignor its respective entire right, title and interest in and to the Proprietary Rights on this 7<sup>th</sup> day of April, 2000.
