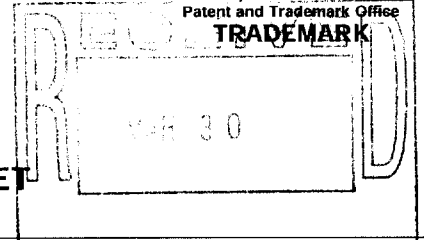

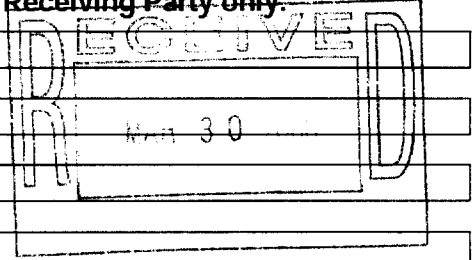

ASSIGNMENT

ComStream Corporation, a Delaware corporation, located at 6350 Sequence Drive, San Diego, California 92121 ("Assignor"), has previously adopted and used in its business the trademark STREAMLINE, for which Assignor has a pending federal trademark application with the United States Patent and Trademark Office, U.S. Trademark Application Serial No. 75/385290, filed October 5, 1997.
