In compliance with the requirements of 15 Pa.C.S. §1915 of the Business Corporation Law of 1988 (relating to articles of amendment), the undersigned business corporation, desiring to amend and restate its Articles of Incorporation, hereby states that:

FIRST: The name of the Corporation is Iron Mountain incorporated.

SECOND: The address of this Corporation's current registered office in this Commonwealth is:

THRD: The Corporation is incorporated under the provisions of the Business Corporation Law of 988, as amended. The date of incorporation of the Corporation was March 5, 1997.

r OURTH: The aggregate number of shares which the corporation shall have the authority to issue is One Hundred Sixty Million (160,000,000) shares, to be divided into One Hundred Fifty Million (10,000,000) shares of Common Stock, par value \$0.01 per share, and Ten Million (10,000,000) shares of Freferred Stock, par value \$0.01 per share.

The Board of Directors is authorized to provide for the issuance of the shares of Preferred Stock as a class without series or in one or more series, and, by filing a statement pursuant to pplicable law of the Commonwealth of Pennsylvania, to establish from time to time the number of shares to be included in each such class or series, and to fix the designations, powers, preferences and rights of the shares of each such class or series.

Any or all classes and series of shares, or any part thereof, may be represented by uncertificated shares to the extent determined by the Board of Directors, except that shares represented by a certificate that is issued and outstanding shall continue to be represented thereby until the certificate is surrendered to the Corporation.


