

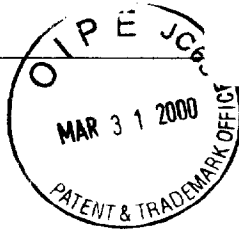



Trademark Assignment made this 30th day of March, 2000.
