DEED OF ASSIGNMENT



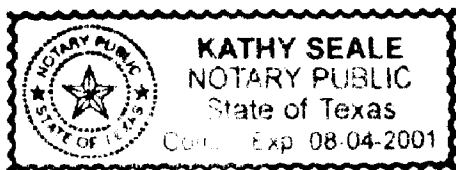
