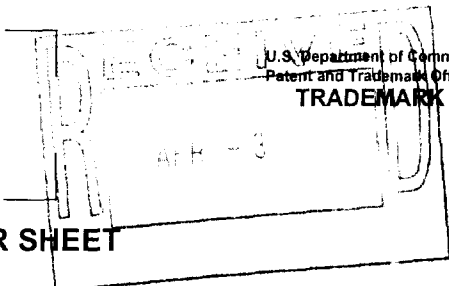

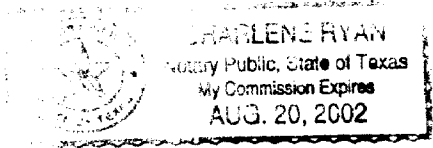
NOW THIS DEED WITNESSETH AS FOLLOWS:
