

ASSIGNMENT OF FEDERAL TRADEMARKS, ETC. AGREEMENT

THIS ASSIGNMENT OF FEDERAL TRADEMARKS, ETC. AGREEMENT (the "Agreement"), made and entered into this 29th day of June, 1995, by and among TAMPA BAY AREA NFL FOOTBALL, INC., a Florida corporation ("Football" or "Assignor"), TAMPA BAY BUCCANEERS, INC., a Florida corporation ("TBBI" or "Assignor", and collectively with Football the "Assignors"), and BUCCANEERS LIMITED PARTNERSHIP, a Delaware limited partnership (the "Assignee").

WITNESSETH:

WHEREAS, pursuant to that certain Letter Agreement dated January 16, 1995, as amended (the "Letter Agreement"), by and among the Assignors and the Assignee, the Assignors agreed to sell all of their right, title and interest in and to the Tampa Bay Buccaneers NFL football team to the Assignee; and

WHEREAS, as part of the sale contemplated in the Letter Agreement, the Assignors desire to enter into this Agreement in order to transfer and convey all of their right, title and interest in and to certain trademarks, tradenames, copyrights, logos and similar property to the Assignee.

AGREEMENT

NOW, THEREFORE, in consideration of the sum of Ten and No/100ths Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. The Assignors hereby grant, transfer, assign and set over to the Assignee, its successors and assigns, forever, all of the right, title and interest of either or both of the Assignors in and to the Assigned Property (as such term is defined herein below).

2. For purposes of this Agreement, the term "Assigned Property" shall mean all of the interests of Assignor in and to any trademark, tradename, copyright, logo or similar property, asset or interest arising from or related to the conduct or operation of the Tampa Bay Buccaneers NFL football team, including, but not limited to, those trademarks described on Exhibit A attached hereto.

3. This Agreement shall inure to the benefit of the Assignee, its successors and assigns, and shall be binding upon the Assignors and their respective successors and assigns.

4. The Assignor hereby agrees to execute such additional documents and do such additional things as may be necessary to register, file or report the assignment of the Assigned Property to Assignee as contemplated hereby, and to vest title in the Assigned Property to Assignee.

5. The Assignee acknowledges that the Assigned Property is subject to that certain License Agreement dated October 1, 1982, by and between Football, the National Football League and National Football League Properties, Inc., whereby National Football League Properties, Inc. has been granted a license to use the Assigned Property as part of merchandising, advertising, promotional and publishing activities associated with the National Football League.



This Agreement shall not amend or nullify the terms or conditions of the Letter Agreement, which shall remain in full force and effect.

7. This Agreement shall be governed by and construed and enforced in accordance with the laws of the State of Florida.


