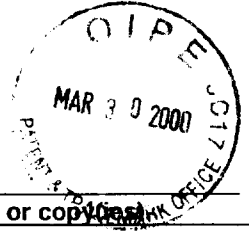

**NOTICE OF TERMINATION OF
SECURITY INTERESTS IN TRADEMARKS**

WHEREAS, **SNYDERGENERAL CORPORATION**, a Minnesota corporation (predecessor in interest to **AAF-MCQUAY, INC.**, a Delaware corporation), with its chief executive office at 215 Central Avenue, Louisville, Kentucky ("Owner"), has granted and conveyed unto **THE BANK OF NOVA SCOTIA**, a Canadian chartered bank ("ScotiaBank"), as administrative agent (ScotiaBank in such capacity, the "Administrative Agent") pursuant to that certain Credit Agreement dated as of July 21, 1994, among the Owner, SnyderGeneral Canada, Inc., the various financial institutions as are, or may from time to time become, parties thereto (individually a "Lender" and collectively the "Lenders"), ScotiaBank and Bank Bumiputra Malaysia Berhad, New York Branch ("BBMB") as the managing agents (the "Managing Agents") for the Lenders (the Administrative Agent being herein referred to as the "Secured Party"), a security interest in and to the trademarks, referred to in Exhibit A (collectively, the "Marks");


WHEREAS, the Secured Party no longer claims any security interests in the Marks or their registrations;


