WHEREAS, the Trademark is the subject of U.S. Serial No. 75/771,327; and

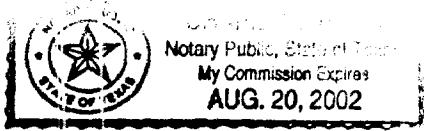

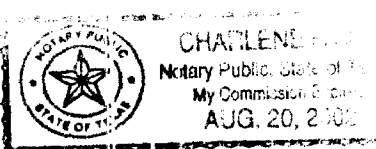


