Erie Scientific Company, a corporation incorporated February 6, 1986, pursuant to the provisions of the General Corporation Law of the State of Delaware DOES HEREBY CERTIFY that:

FIRST: This corporation owns 100% of the capital stock of Stahmer, Weston & Co., Inc., a corporation incorporated June 27, 1985, pursuant to the provisions of the New Hampshire Business Corporation Act.

SECOND: This corporation, by a resolution of its Board of Directors duly adopted by unanimous written consent on the 26<sup>th</sup> day of April, 1999, determined to and did merge into itself said Stahmer, Weston & Co., Inc., which resolution is in the following words to wit:

FURTHER RESOLVED, that any one of the appropriate officers of this corporation is hereby authorized and directed to make and execute a Certificate of Ownership and Merger setting forth a copy of these resolutions and the date of their adoption, and to file and record the same with the Delaware Secretary of State and the New Castle County Recorder of Deeds;

FURTHER RESOLVED, that the Plan of Merger, a copy of which is attached hereto as Exhibit A, is hereby approved and adopted;

FURTHER RESOLVED, that any one of the appropriate officers of this corporation is hereby authorized and directed to make and execute appropriate Articles of Merger and to file the same with the New Hampshire Secretary of State;

FURTHER RESOLVED, that the officers of this corporation are hereby authorized and directed to do all acts which they in their discretion shall deem necessary and appropriate to cause the merger described above to become effective under the laws of the States of Delaware and New Hampshire.

THIRD: The effective time of the merger referred to herein shall be 11:59 p.m. EDT on April 30, 1999.


