ASSIGNMENT OF TRADEMARK

THIS ASSIGNMENT OF TRADEMARK is made as of the 15th day of March, 2000 by and between HASBRO, INC., having its principal place of business at 1027 Newport Avenue, Pawtucket, Rhode Island 02862 (the "Assignor") and GEOFFREY, INC., having its principal place of business at 461 From Road, Paramus, New Jersey 07652 (the "Assignee").

WHEREAS, Assignor is the sole and exclusive owner of all right, title and interest in and to the mark JESSIE and U.S. Registration No 1,221,028 for use in connection with dolls (the "Mark"); and

WHEREAS, Assignee desires to acquire Assignor's entire, right, title and interest in and to the Mark, the registration therefore and the goodwill associated therewith.

NOW, THEREFORE, the Assignor and Assignee agree as follows:

1. For the sum of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by the Assignor, Assignor hereby grants and assigns to Assignee all of Assignor's right, title and interest in and to the Mark, the registration therefore, and any renewals and extensions that may be granted thereon, together with the goodwill of the business connected therewith and any right to recover for past infringements thereof.
2. Assignor represents and warrants that to the best of its knowledge and belief (a) it is the sole and exclusive owner of the Mark and the registration therefore; (b) the federal registration of the Mark is valid and subsisting; (c) the Mark does not infringe the intellectual property rights of any third party; and (d) there are no claims, judgments, or settlements to be paid by Assignor or pending claims or litigation relating to the Mark.
3. Assignor agrees that it will, at no further charge to Assignor, execute an assignment in the form annexed hereto and any other documents, papers, forms and authorizations which may be required by Assignee to effectuate this Agreement or record the assignment of the Mark with the U.S. Patent and Trademark Office.
4. This Assignment of Trademark represents the entire understanding of the parties with respect to the Mark and may not be modified except by a further written

instrument signed by both parties hereto.
