## TRADEMARK ASSIGNMENT

WHEREAS, Fort James Operating Company, a corporation duly organized and existing under the laws of the Commonwealth of Virginia and having its principal office at 1650 Lake Cook Road, Post Office Box 89, Deerfield, Illinois 60015-0089, hereinafter referred to as "ASSIGNOR", owns the marks listed on Schedule A attached hereto and incorporated by reference herein (the "Marks"), together with the goodwill of the business in connection with which the Marks have been used (the "Goodwill").

WHEREAS, Fort James Corporation, a corporation duly organized and existing under the laws of the Commonwealth of Virginia and having its principal office at 1650 Lake Cook Road, Post Office Box 89, Deerfield, Illinois 60015-0089, hereinafter referred to as "ASSIGNEE", desires to acquire the Marks, together with the Goodwill.

WHEREAS, ASSIGNOR desires to assign the Marks and the Goodwill to ASSIGNEE as a transfer of assets related to the merger between Fort Howard Corporation and ASSIGNEE, completed as of the Effective Date of this Assignment, December 29, 1997.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, ASSIGNOR has agreed to and has hereby assigned to ASSIGNEE and its successors and assigns ASSIGNOR's entire right, title, and interest in and to the Marks and the Goodwill, to be held and enjoyed by ASSIGNEE for its own use and benefit and for the use and benefit of its subsidiaries, licensees, successors, assigns, and legal representatives, for the full extent of the lives of the Marks, to be used as fully and entirely as such rights would have been held and enjoyed by ASSIGNOR had this Assignment not been made.

ASSIGNOR covenants that ASSIGNOR is the owner of the Marks, that ASSIGNOR has full power to make this Assignment and that ASSIGNOR agrees to execute such further assignments and related documents with respect to the Marks and Goodwill as ASSIGNEE shall reasonably request.

IN WITNESS WHEREOF, ASSIGNOR has caused this Agreement to be executed by its duly authorized officer, to be effective as of December 29, 1997.

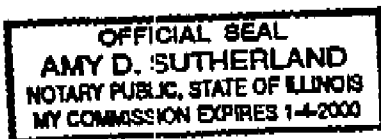
