

WHEREAS, CAPITAL FASTENER, INC. d/b/a Reliant Industries, Inc., a corporation of the state of Michigan, having a principal place of business at 7130 Clinton Road, Loves Park, Illinois 61111, hereinafter called "SELLER", is the owner of the entire equitable and legal right, title and interest, by virtue of SELLER having adopted with continuous use, in and to the mark and name L9 which is registered in the United States Patent and Trademark Office under U.S. Trademark Registration No. 853,983, registered on August 6, 1968 and in the Canadian Patent and Trademark Office under Canadian Trademark Registration No. 241,240, registered on March 14, 1980; and

WHEREAS, BRIGHTON-BEST SOCKET SCREW MFG. INC., a New York corporation having a principal place of business at 20 East Oakdene Avenue, Teaneck, New Jersey 07666-4198, hereinafter called "PURCHASER", is desirous of acquiring the entire equitable and legal right, title and interest, throughout the world, in and to the mark and name L9 and U.S. Trademark Registration No. 853,983 and Canadian Trademark Registration No. 241,240, both for the mark and name L9 (Design), together with the goodwill appurtenant thereto.

NOW, THEREFORE, for the good and valuable consideration as set forth in a separate agreement between the parties entitled "Purchase Agreement Among Brighton-Best Socket Screw Mfg. Inc. and Capital Fastener. Inc., d/b/a Reliant Industries, Inc.", receipt of which is hereby acknowledged, SELLER does hereby sell, assign, transfer and set over unto PURCHASER, all of SELLER's right, title and interest for the United States, its territories, dependencies and possessions, and for all other countries throughout the world, in and to the mark and name L9 and U.S. Trademark Registration No. 853,983 and Canadian Trademark Registration No. 241,240, both for the mark and name L9 (Design), together with the goodwill of the business symbolized by the mark and name L9 and the trademark registrations thereon (hereinafter "L-9 Trademarks and Name"), the same to be held and enjoyed by PURCHASER, PURCHASER's successors and assigns, for PURCHASER's own use and behalf and for the use and behalf of PURCHASER's successors and assigns, as fully and entirely as the same would have been held and enjoyed by SELLER, if this Assignment had not been made, together with all claims for damages by reason of past, present or future infringement of the L-9 Trademarks and Name and the trademark registrations thereon, and the right to use and collect the same for PURCHASER's own use and behalf, and for the use and behalf of PURCHASER's successors and assigns.

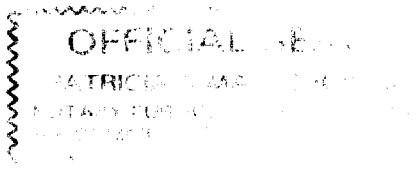
