ASSIGNMENT OF UNITED STATES REGISTERED TRADEMARK

Assignor does further consent to the recordation of this assignment by Assignee with the Commissioner of Patents and Trademarks.

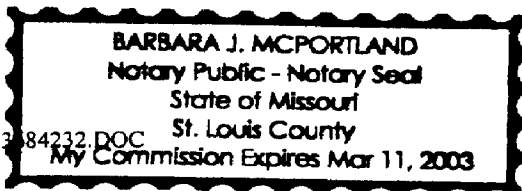
