CERTIFICATE OF AMENDMENT OF  
ARTICLES OF INCORPORATION

The undersigned, Biotronics, Inc., a Missouri corporation (the "Corporation"), for the purpose of amending the Articles of Incorporation of the Corporation, in accordance with The General and Business Corporation Law of Missouri, does hereby make and execute this Certificate of Amendment of Articles of Incorporation and does hereby certify that:

I. The name of the Corporation is Biotronics, Inc., and the name under which it was originally organized was Tens of Kansas City, Inc.

II. The amendment set forth below was adopted by the shareholders of the Corporation on June 30, 1999.

III. The following resolution of the shareholders sets forth the amendment adopted:

RESOLVED, that the Articles of Incorporation of the Corporation be amended by deleting all of the present Article One and inserting in lieu thereof the following Article One:

ARTICLE ONE


The name of the corporation is:




