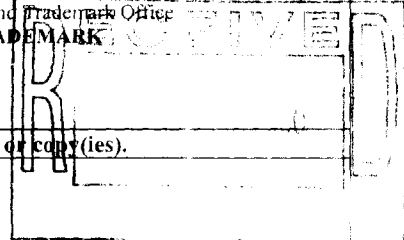



RELEASE OF SECURITY INTEREST


