## TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT (the "Agreement") dated as of January 26, 2000, is made between ERICSSON INC., a Delaware corporation ("Ericsson"), ERICSSON CANADA INC., a Canadian corporation ("ECA") (Ericsson and ECA hereinafter being referred to as the "Seller"), COM-NET ERICSSON CRITICAL RADIO SYSTEMS, INC., a Delaware corporation ("Newco"), and COM-NET ERICSSON CANADA CORP., a Nova Scotia unlimited liability company ("Newco-Canada") (Newco and Newco-Canada hereinafter being referred to as the "Buyer").

A. Ericsson, ECA, Newco and Newco-Canada are parties to an Asset Purchase Agreement dated as of December 23, 1999 (together with subsequent amendments thereto, the "Asset Purchase Agreement"), providing for the sale by Seller to Buyer of certain assets used in the Ericsson Private Radio Systems business, and for the assumption of certain liabilities specified therein.

B. As a condition to the respective obligations of the parties to the Asset Purchase Agreement to consummate the Closing, the Asset Purchase Agreement requires the execution and delivery of this Agreement pursuant to which the Seller assigns certain trademarks upon the terms set forth herein.

NOW, THEREFORE, in consideration of the foregoing, the mutual covenants contained herein, and to fulfill the parties' commitments pursuant to the Asset Purchase Agreement:

1. Seller hereby sells, transfers and assigns all right, title and interest, whether arising from common law, statute, contract or otherwise, in the trade names (the "Names") and the trade marks and service marks (the "Marks"), set forth in Schedules 2.1(b)(i)(b) and 2.1(b)(ii) and including the registrations set forth therein for the goods listed in these schedules, both

attached hereto and incorporated herein by this reference, and in all logos, designs and artwork used in connection with the Names and the Marks (hereinafter "the Logos"), and in all registrations for the Names, the Marks, and the Logos, to the Buyer, together with the goodwill of the business connected with the use of the Names and the Marks and the Logos and symbolized thereby.

2. Seller makes no representation that Names, Marks, and Logos registered remain validly registered. Names, Marks and Logos are assigned AS IS, without warranty.

3. This Agreement, together with the Asset Purchase Agreement and the Related Agreements, constitutes the entire agreement and supersedes all other prior agreements and understandings, both written and oral, between the parties with respect to the subject matter hereof and in the event of a conflict between this Agreement and the Asset Purchase Agreement, the terms of this Agreement shall control.

4. This Agreement may be executed in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.

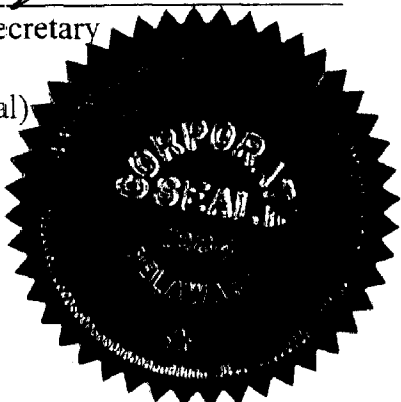

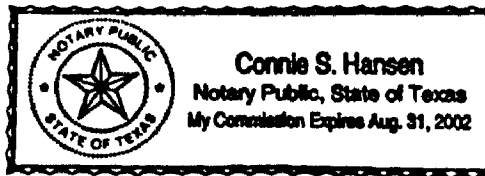
