RELEASE AND REASSIGNMENT OF TRADEMARKS

This Release and Reassignment of Trademarks (this "Release") is made on the 29 day of March, 2000 between ING (U.S.) CAPITAL, LLC, a Delaware corporation, with a place of business at 333 South Grand Avenue, Suite 4200, Los Angeles, California 90071 ("Lender") and THE BEKINS COMPANY, a Delaware corporation with its chief executive office located at 330 South Mannheim Road, Suite 200, Hillside, Illinois 60162 ("Grantor").

W I T N E S S E T H:

WHEREAS Lender and Grantor were parties to that certain Trademark Security Interest Assignment dated February 25, 2000 (the "Security Agreement") which provided, inter alia, for the granting of a security interest in the trademark rights identified on Exhibit A hereto (the "Trademarks") as collateral for a loan, and which assignment was recorded by the U.S. Patent and Trademark Office at Reel 1881, Frame 0188 on April 9, 1999;

WHEREAS Lender has received full payment of the outstanding balance of the loan, and all obligations of Grantor have been satisfied; and

WHEREAS Grantor has requested Lender to release Grantor from its obligations under the Security Agreement, and to reassign to it all Trademarks that were the subject of the Security Agreement.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Grantor and Lender hereby agree as follows:

1. Lender hereby reassigns, transfers and sets over unto Grantor, its successors, assigns and legal representatives, the entire right, title and interest in and to the Trademarks, including, without limitation, trademark applications and registered trademarks, and in and to the goodwill and assets of the business to which each of the Trademarks relate, together with the right to recover for past, present and future infringements thereof.
2. Lender hereby releases Grantor and the Collateral (as defined in the Security Agreement), and reassigns to Grantor all rights and interests transferred under the Security Agreement.
3. Lender represents that it has the full right, power and authority to convey the interests herein reassigned, said interests being that originally conveyed under the Security Agreement, and that it has not executed any assignment in conflict herewith.
4. Lender covenants that it shall, upon Grantor's request, execute and deliver all further documents or instruments as may be necessary or appropriate to confirm, maintain and enforce the Release effected hereby or to otherwise effectuate the purposes hereof.


