**RELEASE OF COLLATERAL
TRADEMARK SECURITY AGREEMENT**

THIS RELEASE is made as of this 21st day of April, 2000, by Antares Capital Corporation f/k/a Antares Leveraged Capital Corp., as agent ("Antares"), in favor of Cerex Advanced Fabrics, L.P. ("Cerex").

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Antares hereby unconditionally and expressly releases, terminates and extinguishes, without limitation, any and all of its right, title and interest in and to, and any and all liens and security interests it may have upon, all of the Trademarks, as defined in the Security Agreement (defined below), interests under Trademark license agreements, Trademark applications, all income, royalties, rights and goodwill thereto, and all of the license agreements, including the right to prepare for sale, sell and advertise for sale, and any and all other items listed in Exhibit A attached hereto, which liens and security interests were established under and pursuant to the Trademark Security Agreement recorded in the U.S. Patent and Trademark office on April 8, 1997 at Reel 1575 Frame 0286 dated as of March 10, 1997 (the "Security Agreement"). All obligations and duties under the Security Agreement to the extent they relate solely to the Trademarks, Trademark applications and Trademark licenses, including without limitation, the items listed on Exhibit A attached hereto, are hereby released and terminated and Antares hereby expressly releases and discharges without limitation all claims, demands and causes of action that it may now have or might subsequently accrue to it arising out of or connected with, directly or indirectly, the Security Agreement to the extent they relate solely to the Trademarks, Trademark applications and Trademark licenses, including without limitation, the items on Exhibit A attached hereto.

This Release shall be binding upon Antares' legal representatives, assigns and successors.
