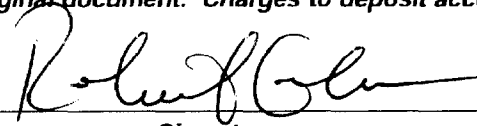

- 1. The name of the corporation is HUBCO, Inc. (hereinafter the "Corporation").
- 2. Article I of the Certificate of Incorporation is hereby amended to read as follows:

1. The name of the corporation shall be Hudson United Bancorp (hereafter, the "Corporation").

3. The foregoing amendment to the Certificate of Incorporation was approved by the board of directors and thereafter duly adopted by the shareholders of the Corporation on the 21st day of April, 1999.

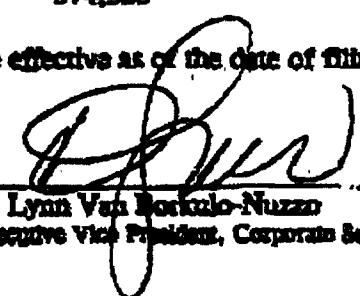
