**DECLARATION**

SIR:

I, C.J. Visser declare that:

1. I am an independently authorised director of Clarins B.V., which company is the only director of Loris Azzaro B.V., a corporation of the Kingdom of the Netherlands.
2. I am aware of the circumstances of transfer of title of the EAU BELLE D'AZZARO mark.
3. Loris Azzaro B.V. is the current owner of the EAU BELLE D'AZZARO mark.
4. Application was made to register the EAU BELLE D'AZZARO mark in the U.S. Patent and Trademark Office on May 20, 1996 by Parfums Loris Azzaro S.A., a corporation of the Republic of France.
5. Ownership of the mark was transferred by Assignment on December 31, 1996 from Parfums Loris Azzaro S.A. to Parfac Parfums & Accessoires GmbH & Co. KG (hereinafter "Parfac Parfums") a corporation of the Republic of Germany.
6. The December 31, 1996 Assignment contained an undetected typographical error indicating Parfac Parfums was a corporation of the Republic of France.
7. Ownership of the mark was transferred by Assignment on December 9, 1997 by Parfac Parfums to Loris Azzaro B.V., a corporation of the Kingdom of the Netherlands.
8. Parfac Parfums is correctly identified as a corporation of the Republic of Germany in the December 9, 1997 Assignment.
9. It appears as if an Assignment from Parfac Parfums of France to Parfac Parfums of Germany is missing.
10. Parfac Parfums was a corporation of the Republic of Germany both at the time of the December 31, 1996 Assignment and the time of the December 9, 1997 Assignment.
11. There is no break in assignment from the original applicant, Parfums Loris Azzaro S.A., a corporation of the Republic of France, to Parfac Parfums, a corporation of the Republic of Germany and from the last mentioned company to the present owner, Loris Azzaro B.V., a corporation of the Kingdom of the Netherlands.
