**RELEASE OF
COMPANY TRADEMARK COLLATERAL SECURITY AGREEMENT
AND CONDITIONAL ASSIGNMENT**

This **RELEASE OF COMPANY TRADEMARK COLLATERAL SECURITY AGREEMENT AND CONDITIONAL ASSIGNMENT** (this "Release") is entered into as of March 27 2000 by and between **DIAMOND TRIUMPH AUTO GLASS, INC.** ("Grantor") and **BANKERS TRUST COMPANY** ("Secured Party").

WHEREAS, pursuant to that certain Company Trademark Collateral Security Agreement and Conditional Assignment dated as of March 31, 1998 made by Grantor in favor of Secured Party, Grantor assigned and granted to Secured Party a security interest in all of Secured Party's trademarks and service marks and in the business symbolized by the marks as collateral security for certain credit extended by Secured Party to Grantor;

1. 2. Secured Party further releases its security interest, lien, assignment and all other encumbrances of Grantor's right, title and interest in and to all renewals and extensions of the Marks and all proceeds thereof.


