ASSIGNMENT OF TRADEMARK

WHEREAS, Metachem Products, LLC, a Delaware corporation, having an address of 745 Governor Lea Road, New Castle, Delaware 19720 (hereinafter referred to as "ASSIGNOR"), is the owner of the trademark and the record owner of Trademark Application Serial No. 75/642,861 for the trademark SEPTIC-FLOW (hereinafter referred to as the "TRADEMARK"); and

WHEREAS, Hercules Chemical Company, Inc., a New Jersey corporation, having an address of 111 South Street, Passaic, New Jersey 07055 (hereinafter referred to as "ASSIGNEE"), is desirous of acquiring all of the rights, title and interest of ASSIGNOR in, to and under the TRADEMARK, together with the goodwill of the business associated with the TRADEMARK;

NOW THEREFORE, in consideration of good and valuable consideration from ASSIGNEE to ASSIGNOR, the sufficiency and receipt of which is hereby acknowledged, ASSIGNOR confirms the transfer and hereby transfers and assigns to ASSIGNEE, the entire right, title and interest in and to the TRADEMARK, together with the goodwill of the business associated with the TRADEMARK and all trademark registrations therefor; and

ASSIGNOR does also hereby sell, assign, transfer and set over unto ASSIGNEE, its successors, legal representatives and assigns, all claims for damages by reason of past infringement of the TRADEMARK, the right to sue for and collect the same for its own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives; and

ASSIGNOR, further authorizes the Commissioner of Patents and Trademarks of the United States, and any official of any country foreign to the United States, whose duty it is to record trademark registrations, applications and title thereto, to record the TRADEMARK and title thereto as the property of the ASSIGNEE, its successors, legal representatives and assigns in accordance with the terms of this instrument; and

ASSIGNOR, further agrees to execute such addition documents as may be required in countries foreign to the United States, to record ASSIGNEE as the owner of the TRADEMARK and registrations and applications herein assigned.
