

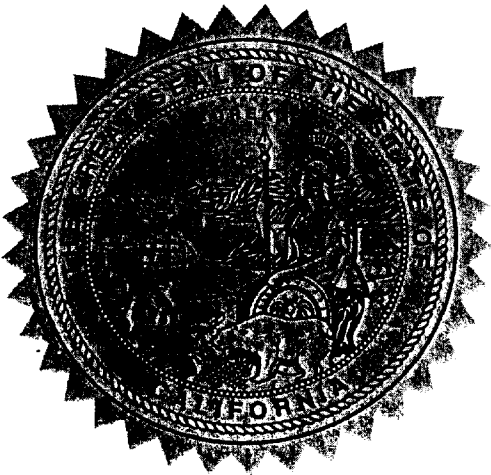

Michael L. Hackworth and Paul A. Blumenstein hereby certify as follows:


1. They are the President and Secretary, respectively, of Digital Tools, Incorporated, a California corporation (the "Corporation").

2. Article I of the Articles of Incorporation of the Corporation is amended to read in its entirety as follows:


"The name of the Corporation is 'Aspirian, Inc.'"
