

ASSIGNMENT

THIS ASSIGNMENT, effective as of the 30th day of September, 1999, by and between Armstrong World Industries, Inc., a corporation organized and existing under the laws of the Commonwealth of Pennsylvania, having an office at 2500 Columbia Avenue, Lancaster, Pennsylvania 17603 (hereinafter Seller), and Day International, Inc., a corporation organized and existing under the laws of the State of Delaware, having an office at 130 West Second Street, P. O. Box 338, Dayton, Ohio 45401-0338 (hereinafter BUYER).

WITNESSETH:

WHEREAS, Seller, Armstrong World Industries, G.m.b.H. and BUYER have entered into a Purchase Agreement dated July 29, 1999 (the "Purchase Agreement"), for the purchase of the Business (as defined in the Purchase Agreement);

WHEREAS, the Purchase Agreement provides for the conveyance of certain assets, rights and properties of Seller to BUYER;

WHEREAS, pursuant to the Purchase Agreement, Seller has agreed to assign certain patents, patent applications, trademarks, trademark applications, licenses and copyright rights set forth below (the "Intellectual Property") to BUYER upon the terms and conditions set forth below and in the Purchase Agreement;

WHEREAS, Seller is the sole and exclusive owner of the Intellectual Property set forth below; and

WHEREAS, BUYER wishes to acquire all of the Seller's right, title and interest in the Intellectual Property.

NOW, THEREFORE, in consideration of the following terms and covenants, the parties agree as follows:

1. Definitions

The terms set forth below shall have the following meanings when used in this Assignment:

1.1 "U.S. Patents" shall mean the United States patents, reissues and reexaminations listed on attached Schedule 2.1(b)(iii).

1.2 "U.S. Patent Applications" shall mean the United States patent applications listed on attached Schedule 2.1(b)(iii), all divisions, continuations-in-part of said applications and all patents which may subsequently be granted on any of said U.S. patent applications and all reissues, extensions, and reexaminations thereof.

1.3 "Foreign Patents" shall mean the foreign patents and registrations of patents listed on attached Schedule 2.1(b)(iii).

1.4 "Foreign Patent Applications" shall mean the foreign patent applications listed on attached Schedule 2.1(b)(iii), all divisions, continuations, continuations-in-part of said applications and all patents which may subsequently be granted on any of said foreign patent applications and all reissues, extensions, reexaminations and registrations thereof.

1.5 "Patents" shall mean the U.S. Patents and the Foreign Patents.

1.6 "Patent Applications" shall mean the U.S. Patent Applications and the Foreign Patent Applications.

1.7 "U.S. Trademarks" shall mean the United States registered trademarks and applications therefor listed on attached Schedule 2.1(b)(iii) and all goodwill associated therewith.

1.8 "Foreign Trademarks" shall mean the foreign registered trademarks and applications therefor listed on attached Schedule 2.1(b)(iii) and all goodwill associated therewith.

1.9 "Trademarks" shall mean the U.S. Trademarks and the Foreign Trademarks.

1.10 "Licenses" shall mean the licenses and secrecy agreements listed on attached Schedule "AGREEMENTS".

1.11 "Business" shall mean the assets of the Worldwide Textile Products Operation of Seller.

All other initial capitalized terms not specifically defined herein shall have the same meanings as set forth in the Purchase Agreement.

2. Assignment

2.1(a) Seller does hereby sell, convey, transfer, assign and deliver to BUYER all right, title and interest of Seller in, to, and under:

(i) the Patents, and Patent Applications, including but not limited to the right to make, to use and to vend, the patent (including design patents, industrial designs and utility models);

(ii) the Trademarks, subject to paragraph 2.1(c), and the goodwill of the business associated therewith;

(iii) the common law mark PRESS FIT and the goodwill of the business associated therewith; and

(iv) the unregistered copyright rights that are owned by the Seller and used solely in connection with the Business,

in each case, together with all rights to apply for registration thereof in foreign countries with full benefit of such priority as may now or hereafter be granted to it by law, treaty or other international convention, and all rights, interests, claims and demands recoverable in law or equity, that Seller has or may have in profits and damages for past, present and future infringements of the Patents, the Patent Applications or the Trademarks, including, but not limited to, the right to compromise, sue for and collect such profits and damages, all of the foregoing to be held and enjoyed by BUYER, its successors and assigns or their legal representatives, as fully and entirely as the same would have been held and enjoyed by Seller if this Assignment had not been made.

2.1(b) Seller hereby assigns and transfers to BUYER all right, title and interest of the Seller in, to and under the Licenses.

2.1(c) With respect only to those certain Trademarks of the mark ACCOTEX that are registered in India, Bhutan, Sri Lanka, Bangladesh, and Nepal, (the "Accotex Trademarks") the assignment of Trademarks under Section 2.1(a) shall be limited to an assignment of the Seller's right, title and interest therein after April 1, 2003 after which date all terms and conditions of this Assignment shall apply with respect thereto with full force and effect. Seller hereby agrees that it will not (i) alienate, transfer or otherwise encumber any beneficial or legal interest in the Accotex Trademarks assigned to the BUYER hereunder, or (ii) conduct or fail to take any other act that will prejudice the ability of the BUYER to take full operating control and actual possession of the Accotex Trademarks free of charge on April 1, 2003.

2.2 BUYER shall be responsible, at their own expense, for the preparation, legalization and recording of any documents and the obtaining of any third-party or governmental approvals or consents not required to be obtained by Seller under the Purchase Agreement which may be necessary to effect and record the assignment or transfer of any of the Patents, Patent Applications, Trademarks and Licenses to BUYER, and Seller hereby appoints BUYER as Seller's attorney-in-fact, irrevocably and coupled with an interest, to execute, acknowledge, deliver and record any documents or instruments necessary to effect such assignment.

2.3 Seller will use reasonable efforts to physically deliver a complete copy of all documentation relating to the Intellectual Property assigned hereunder to BUYER within one (1) month after the execution of this Assignment.

3. Force Majeure

Except as otherwise specifically provided for, Seller shall not be liable to BUYER for its failure to perform or delay in performing its obligations hereunder due to any event beyond its reasonable control, including, without limitation, acts of God, fires, wars, acts of war, sabotage, terrorism, labor disputes or shortages, governmental laws, ordinances, rules or regulations (whether valid or invalid), and any other similar event (hereinafter referred to as Force Majeure). Seller shall notify BUYER as soon as reasonably possible of such event, setting forth the full particulars, shall to the extent practicable remedy such occurrence with reasonable dispatch (however, Seller shall not be required to settle strikes, lockouts, or other labor difficulties contrary to its wishes), and shall promptly give notice to BUYER of the cessation of such occurrence.

4. Applicable Law

This Assignment, and the rights and obligations of Seller and BUYER hereunder, shall be governed by and construed in accordance with the laws of the United States with respect to intellectual property issues and in all other respects in accordance with the laws of the State of New York without reference to its conflict of laws, rules or principles.

5. Notices

All notices required and other communications under this Assignment shall be in writing and shall be deemed given when delivered personally or four days after being mailed by registered mail, return receipt requested, to a party at the following address (or to such other address as such party may have specified by notice given to the other party pursuant to this provision):

or to such other addresses of which either party may notify the other party in writing. The Post Office receipt showing the date of such deposit shall be prima facie evidence of these facts. All such notices shall be deemed to have been given on the date shown on the Post Office receipt for deposit.

6. Representations

All representations made by Seller to BUYER in the Purchase Agreement with respect to the rights assigned hereunder remain in full force and effect. The execution of this Assignment does not modify the Purchase Agreement.

7. Further Assurances

Seller shall execute and deliver to BUYER such additional instruments, documents, conveyances or assurances and take such other action as shall be necessary or otherwise reasonably requested by BUYER to confirm and assure the rights and obligations provided for in this Assignment and the Purchase Agreement and render effective the consummation of the transactions contemplated hereby and thereby.

8. Entire Agreement, Amendments, Waivers

The terms set forth herein and the two Schedules attached hereto, together with the Purchase Agreement, constitute the entire agreement between the parties with respect to the subject matter of this Assignment and supersede all of the other, previous and contemporaneous representations, understandings and other communications, either oral or written, between the parties with respect to such subject matter.

9. Headings and Captions

The headings and captions used in this Assignment have been inserted for convenience only and shall not affect or be deemed to affect its construction.

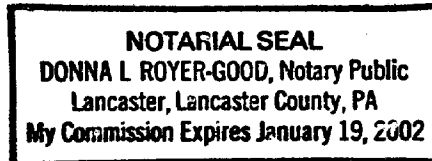
