ASSIGNMENT





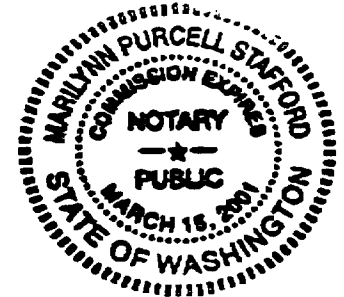
