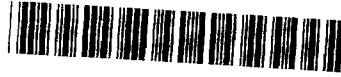

TRADEMARK ASSIGNMENT**

WHEREAS, Mannesmann Dematic Rapistan Corp., a New York Corporation (formerly doing business as Rapistan Incorporated, a Michigan corporation, and as The Rapids-Standard Company, Inc., a Michigan corporation), having a place of business at 507 Plymouth Avenue, N.E., Grand Rapids, Michigan 49505 (hereafter "Assignor"), was the owner of the following trademark (hereafter "Mark") in the United States:

McDonald, Vice President, on July 26, 1990, which was recorded in the United States Patent and Trademark Office at Reel 0728, Frame 959 on August 3, 1990;

WHEREAS, the above-noted incomplete corporate name occurred as a result of an inadvertent failure to notice such incomplete name at the time the original Assignment was prepared and signed by the Assignor;

WHEREAS, the proper name for Assignee corporation is Globe of Michigan Inc.;


