Trademark Assignment Agreement

Dated December __, 1998

This is a Trademark Assignment Agreement between Phillips-Van Heusen Corp., a Delaware corporation (the "*Assignor*"), and Saks Incorporated, a Tennessee corporation (the "*Assignee*").

Terms and Conditions

In consideration of Assignee's payment of \$100 to Assignor and other valuable consideration, which Assignor acknowledges having received, Assignor and Assignee agree as follows:

1. *Assignment and Further Assistance.* Assignor sells, assigns, and transfers to Assignee all of Assignor's rights, title, and interest to the United States trademark "Cezani", which is registered in the United States Patent and Trademark Office, Registration No. 1869666 dated December 27, 1994 for neckwear and shirts (the "Trademark"), together with (a) the goodwill of the business symbolized by the Trademark and (b) the registration. Assignor will perform all acts deemed necessary or desirable by Assignee to permit and assist Assignee, at Assignee's expense, to perfect and enforce Assignee's rights, title, and interest to the Trademark.

2. *Representations and Warranties.* Assignor represents and warrants to Assignee as follows:

- a) Assignor is the exclusive owner of Registration No. 1869666.
- b) Assignor has full power and authority to enter into this Agreement.
- c) This Agreement transfers to and vests in Assignee good, valid, and marketable title to the Trademark, free and clear of all licenses.

3. *Past Infringements.* Assignor assigns to Assignee the right to bring an action for any past infringement of the Trademark and to collect and hold for Assignee's sole use forever all monetary recoveries from the infringement actions.

4. *Entire Agreement.* This Agreement and the contemporaneous letter agreement is the entire agreement between the parties relating to this subject matter and supersedes all prior or simultaneous representations, discussions and agreements, whether written or oral.

5. *Choice of Law.* This Agreement will be governed by and construed in accordance with Alabama law without giving effect to choice of law provisions.

6. *Severability.* If any part of this Agreement is found invalid or unenforceable, that part will be amended to achieve as nearly as possible the same economic effect as the original provision and the remainder of this Agreement will remain in full force and effect.


