## **RELEASE AND REASSIGNMENT**

This **RELEASE AND REASSIGNMENT** is granted on this 30th day of June, 2000 by Union Bank of California, N.A. a California corporation, with a place of business at 445 South Figueroa Street, Los Angeles, California 90071 ("Assignor") in favor of Mobile Storage Group, Inc., a California corporation having a place of business at 2540 Foothill Boulevard 2<sup>nd</sup> Floor, La Crecenta, California 91214 ("Assignee"), for the ratable benefit of the Lenders, as defined in the Credit Agreement (as defined below).
