## CONFIRMATION ASSIGNMENT

THIS CONFIRMATION ASSIGNMENT (this "Assignment") is made as of April 5, 2000 by and between the Estate of Robert W. Franklin ("Assignor") and Leallah M. Franklin, an individual residing in Tucson, Arizona ("Assignee").

WHEREAS, the Assignor was the owner of the service mark RENTCENTER & Design (the "Mark") and the United States Federal Registration therefor ("Reg. No. 723,393"); and

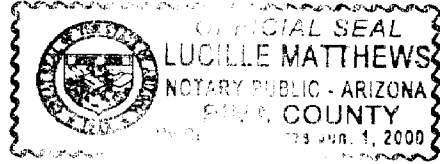
