TRADEMARK SECURITY AGREEMENT

THIS AGREEMENT is made on the 12 day of April, 2000, by and between Synbiotics Corporation, a CALIFORNIA corporation having a mailing address at 11011 VIA FRONTERA, SAN DIEGO CA 92127 ("Grantor"), and Imperial Bank ("Grantee"), with an address at 695 Town Center Drive, Costa Mesa, California 92626.

BACKGROUND

WHEREAS, pursuant to the terms of that certain Commercial Security Agreement dated as of APRIL 12, 2000 (as amended, modified, restated or supplemented from time to time, the "Security Agreement"), and to secure the obligations of Grantor under certain other documents executed in connection therewith (as amended, modified, restated or supplemented from time to time, the "Loan Documents"), Grantor has pledged and mortgaged to, and has granted Grantee a continuing security interest in and to, certain assets of Grantor, including without limitation, all right, title and interest of Grantor in and to all registered trademarks, service marks and pending applications shown in the attached Exhibit A, and those trademarks and service marks which are hereafter adopted or acquired by Grantor, and all right, title and interest therein and thereto, and all registrations, applications, and recordings thereof, including, without limitation, applications, registrations and recordings in the United States Patent and Trademark Office or in any similar office or agency of the United States, any State thereof, and any foreign country all whether now owned or hereafter acquired by Grantor (collectively, "Trademarks");

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, as collateral security for the prompt payment of the obligations under the Loan Documents, Grantor hereby grants and conveys to Grantee a security interest in and to (a) the entire right, title and interest of Grantor in and to the Trademarks, including the registrations and applications appurtenant thereto, listed in Exhibit A hereto (as the same may be amended pursuant hereto from time to time), and in and to any and all trademarks, and registrations and applications appurtenant thereto, hereafter acquired or filed by Grantor, including without limitation all renewals thereof, all proceeds of infringement suits, the rights to sue for past, present and future infringements and all rights corresponding thereto in the United States and any foreign country and the goodwill of the business to which each of the Trademarks relates and (b) all of Grantor's right, title and interest in, to and under the following:

(i) all trademark license agreements of Grantor designated on Exhibit A hereto, as any of the same may from time to time be amended or supplemented Licenses;

(ii) all receivables, contract rights and general intangibles arising under or relating to each and every License (including, without limitation, (A) all moneys due and to become due under any License, (B) any damages arising out of or for breach or default in respect of any such License, (C) all other amounts from time to time

paid or payable under or in connection with any such License, and (D) the right of Grantor to terminate any such License or to perform and to exercise all remedies thereunder); and,

(iii) to the extent not otherwise included, all proceeds and products of any or all of the foregoing. All of the foregoing property referred to hereinafter collectively as the "Trademark Collateral."

It is expressly understood and agreed that the Trademark Collateral granted hereunder shall include, without limitation, rights and interests pursuant to licensing or other contracts in favor of Grantor pertaining to the Trademarks now or in the future owned or invented by third parties and Grantor grants Grantee a power-of-attorney, irrevocable so long as the Loan Documents are in existence, to modify this Trademark Security Agreement by amending Exhibit A to include any future property to be covered by this Trademark Security Agreement.

Grantor represents and warrants to Grantee that as of the date of this Trademark Security Agreement, Grantor does not own any Trademarks that are registered, or applied for registration, with the United States Patent and Trademark Office or in any similar office or agency of the United States, any State or Territory thereof, or any other country or political subdivision other than the Trademarks listed in Exhibit A attached hereto.

Except as expressly permitted under the Security Agreement, Grantor agrees not to sell, license, exchange, assign or otherwise transfer or dispose of, or grant any rights with respect to, or mortgage or otherwise encumber, any of the foregoing Trademark Collateral.

Grantor hereby agrees, without the necessity of any further consideration whatsoever, to execute, acknowledge and deliver all such further instruments and to take all such further actions as may be reasonably required in order more fully and effectively carry out the purposes of this instrument and to vest in Grantee all rights hereby granted. Grantor hereby irrevocably constitutes and appoints Grantee its true and lawful attorney, in its name, place and stead, to make, execute, acknowledge, file, record and deliver any and all documents (including without limitation assignment documents) which would enable Grantor to protect or perfect its interest in the Trademark Collateral, which power of attorney is expressly coupled with an interest.

The security interests granted hereunder have been made in conjunction with the security interests granted to Grantee pursuant to the Security Agreement. Grantor hereby acknowledges and affirms that the rights and remedies of Grantee with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.
