AMENDED AND RESTATED LICENSE AGREEMENT

AMENDED AND RESTATED LICENSE AGREEMENT dated as of the 24th day of April, 1996 by and between PUBLICATIONS BONNIER SNC ("Licensor") with its head office at 20, Rue de Billancourt, Boite Postale 406, F1-92108 Bologne Billancourt, France, here represented by its General Manager, Mr. Daniel Bonnier, and MEIGHER COMMUNICATIONS, L.P. ("Licensee"), a Delaware limited partnership with its head office at 100 Avenue of the Americas, New York, New York 10013, here represented by Meigher, Peabody & Company, Inc., its General Partner.

W I T N E S S E T H :

WHEREAS, Licensor is the owner of the trademarks "SAVEURS" and "SAVEUR" (the "Licensed Trademarks"); and

WHEREAS, Licensor publishes an internationally renowned high-quality French food and travel magazine (the "Magazine") using the trademark "SAVEURS" as its title which, in addition to the material contained therein, is known to the parties; and

WHEREAS, Licensor and Licensee entered into a License Agreement in July, 1994 (the "Initial License Agreement") which granted Licensee a license to use the Licensed Trademarks; and

WHEREAS, Licensor and Licensee desire to amend and restate the License Agreement.

1. LICENSE

- 1.1 Licensor grants to Licensee an exclusive license to use the Licensed Trademarks in the Territory (as hereinafter defined) as the title of English language magazines (each such magazine having one of the Licensed Trademarks as the title may hereinafter be referred to as a "Licensed

Magazine") and also for ancillary English language products emanating from the publishing activity of the Licensed Magazines or otherwise consistent in content and approach with the Licensed Magazines including, but not limited to, books, travel guides, on-line services, CD-ROM products, television shows, cable television programs and videotapes (such products, together with the Licensed Magazines, may hereinafter be referred to as the "Licensed Products").

- 1.3 Licensor agrees during the term of this Agreement not to grant to anyone other than Licensee the right to use the Licensed Trademarks in the United States or Canada in connection with any product in any language.
