TRADEMARK ASSIGNMENT, made as of January 21, 2000, between Meigher Communications, L.P., a Delaware limited partnership ("Assignor"), and World Publications, LLC, a Delaware limited liability company ("Assignee").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells, assigns and transfers to Assignee, its successors and assigns, absolutely and forever, its entire right, title and interest, whether statutory or at common law, in and to the Marks throughout the world, together with the goodwill of the business symbolized by them, including but not limited to all causes of action for any and all previously occurring infringements of the rights being assigned and the right to receive and retain the proceeds relating to those infringements.

Assignor agrees to execute any further documents and to do such other acts as may be necessary and proper to vest full title in and to the Marks in the Assignee.
