



## TRADEMARK ASSIGNMENT

WHEREAS, Genuity, Inc., a corporation organized and existing under the laws of Nevada and having a place of business at 50 California Street, San Francisco, California 94111 (now, by change of name, BEn Dissolveco, Inc., and hereinafter "ASSIGNOR"), had adopted the trademark GENUITY, which was the subject of United States Application No. 75/081,054 filed on March 29, 1996 which subsequently issued as Registration No. 2,237,047 on April 6, 1999 at the United States Patent and Trademark Office; and


WHEREAS, on December 5, 1997, ASSIGNOR conveyed unto BBN Corporation, a corporation organized and existing under the laws of the Commonwealth of Massachusetts, having a place of business at 3 Van de Graaf Drive, Burlington, Massachusetts 01803 (hereinafter "ASSIGNEE"), all rights, title and interest in and to the aforesaid trademark GENUITY, together with the right to file the aforesaid trademark in foreign countries (subject, however, to applicable trademark laws in such foreign countries), the goodwill of the business symbolized by the trademark, the aforesaid application therefor, that portion of ASSIGNOR's business which was associated with the trademark GENUITY, and the right to recover damages for any past and future acts of infringement, and is now desirous of confirming and making of record said conveyance.

NOW, THEREFORE, in consideration of the premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, ASSIGNOR confirms that it sold, assigned, transferred and conveyed and does hereby sell, assign, transfer and convey unto ASSIGNEE all rights, title and interest in and to
