TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (the "Assignment") is made as of this 13 day of July, 1999, by and between BICC Cables Corporation, a Delaware corporation ("Assignor") and BICC General Cable (USA), LLC, a Delaware limited liability corporation ("Assignee").
