

WHEREAS, REON was formed as a Delaware corporation on February 2, 2000.


WHEREAS, Remillard is Chairman, President and Chief Executive Officer of REON.

WHEREAS, REON is the successor to Remillard's business to which the "BLEC" mark pertains.




