

RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Trademark Security Interest Release is granted and conveyed as of April 29, 1999 by Fleet Business Credit Corporation, formerly known as Sanwa Business Credit Corporation, a Delaware corporation, having its principal business at 1 S. Wacker Drive, Suite 3900, Chicago, Illinois 60606 ("Lender"), in favor of Ward Manufacturing, Inc. f/k/a EMI Company, a Pennsylvania corporation having its principal business address at 115 Gullick Street, Blossberg, PA 16912-0009 ("Ward").

WHEREAS, Lender and Ward entered into a Security Agreement on July 5, 1994, under which Ward granted to Lender a security interest in the trademark applications and registrations listed on the attached Schedule A, and the goodwill associated therewith (the "Marks").

WHEREAS, the United States Patent and Trademark Office ("PTO") recorded this Security Agreement on July 6, 1994, against the Marks; and

WHEREAS, Ward has satisfied all of its outstanding obligations under the Security Agreement, and the parties seek to make a record of Lender's release and reassignment to Ward of any and all of its security interest in the Marks.

NOW THEREFORE, for good and valuable consideration, the receipt and adequacy of which the parties acknowledge, Lender hereby (1) releases, discharges and relinquishes, as of April 29, 1999, its security interest in the Marks, and (2) reassigns to Ward, as of April 29, 1999, all right, title, and interest that Lender may have had in the Marks including the goodwill associated with the Marks. Lender specifically acknowledges that the Security Agreement is not longer effective, and that Lender does not own any rights to or have any ownership interest in the Marks.
