NOW, THEREFORE, TO ALL WHOM IT MAY CONCERN, be it known that for good and valuable consideration, the receipt and legal sufficiency of which are hereby acknowledged, the Assignor has sold, assigned, and transferred, and by these presents does sell, assign, and transfer to the Assignee, its successors and assigns the Assignor's entire right, title and interest in and to the Trademarks (including but not limited to the trademark application therefor), identified on Schedule A attached to this Assignment, including the right to bring actions for infringements of the Trademarks occurring prior to the date of this Assignment, together with Assignor's business and of the goodwill of the Assignor's business connected with and symbolized by the Trademarks.
