All obligations and duties under the Security Agreement to the extent they relate solely to the items listed on Exhibit A attached hereto, are hereby released and terminated and SBA hereby expressly releases and discharges without limitation all claims, demands and causes of action that it may now have or might subsequently accrue to it arising out of or connected with, directly or indirectly, the Security Agreement to the extent they relate solely to the items on Exhibit A attached hereto.

This Release shall be binding upon SBA's legal representatives, assigns and successors.


