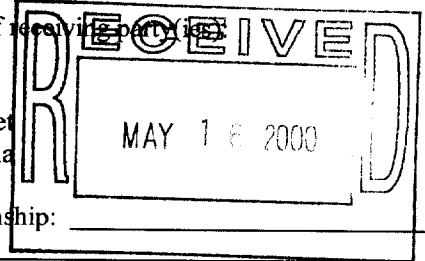

oaths and any other papers which ECO CARE may deem necessary or desirable for securing to ECO CARE or for maintaining for ECO CARE the Trademark hereby acknowledged to have been assigned, and the choses in action therefor, all without further compensation to PAUL MAZZOTTA.
