THIS RELEASE (TRADEMARK) is given as of this ^{24th} day of ~~APRIL~~ ^{APRIL}, 2000 by Truck Components Inc., a Delaware Corporation ("TCI") and American National Bank and Trust Company of Chicago ("ANBT" and together with TCI, "Assignors"), to Gunite Corporation, a Delaware corporation ("Assignee"), as follows:

WHEREAS, ANBT and certain other parties ("Lenders") and TCI entered into a Loan and Security Agreement dated as of May 2, 1994 (the "Loan Agreement") pursuant to which Lenders made advances and offers of credit to TCI;

WHEREAS, Assignee and ANBT entered into a Continuing Guaranty and Security Agreement dated as of May 9, 1994 (the "Guaranty"), pursuant to which Assignee guaranteed the obligations of TCI under the Loan Agreement;

WHEREAS Assignee and TCI entered into an Operating Subsidiary Loan and Security Agreement dated as of May 9, 1994 (the "Operating Subsidiary Loan Agreement"), pursuant to which TCI made extensions of credit to Assignee;

WHEREAS, Assignors and Assignee entered into an Intellectual Property Assignment, dated as of May 9, 1994 (the "Security Agreement"), which was recorded in the United States Patent and Trademark Office on June 15, 1994 at Reel 1167, Frame 0415, and was recorded a second time in the United States Patent and Trademark Office on June 15, 1994 at Reel 1221, Frame 0425, pursuant to which Assignee granted to Assignor a continuing security interest in all of its right, title and interest in and to the Trademark Collateral (as defined in the Security Agreement) referred to in Schedule A thereto, and identified in Exhibit A to this Release, to secure the payment and performance of the Liabilities arising out of the Operating Subsidiary Loan Agreement and the Obligations arising out of the Guaranty (as the Obligations and Liabilities are defined in the Security Agreement); and

WHEREAS, Assignee has fully paid all its Obligations and Liabilities under the Security Agreement and Assignors desire to release their security interests in and liens upon the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignors hereby releases their security interests in and liens upon the Trademark Collateral and reassigns any and all interest it may have in such Trademark Collateral to Assignee.

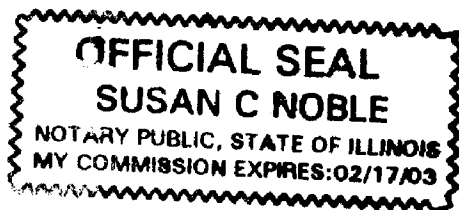

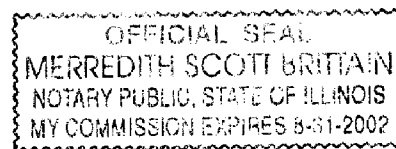
