**Assignment of Trademark**

WHEREAS, Quail Run Cellars & Vintners, a Washington limited partnership, doing business as "Quail Run Vintners," located at 1500 Vintage Road, Zillah, Washington 98953, adopted and began using the mark COVEY RUN ("the Trademark") in commerce for wine at least as early as April 25, 1986, and used the same in commerce continuously through September 30, 1994; and

WHEREAS, on October 18, 1988 the United States Patent and Trademark Office issued Registration No. 1,509,498 to Quail Run Vintners for the Trademark; and

WHEREAS, Quail Run Vintners executed its affidavit under Section 8 of the Lanham Act on September 30, 1994, and caused the same to be transmitted to the United States Patent & Trademark Office; and

WHEREAS, said limited partnership, in the course of modifying its structure, under that certain "Assignment of Trademark Registration" dated September 30, 1994, assigned to its general partner, Quail Run Vintners Inc., a Washington corporation and an affiliated company, all its rights in and to said trademark and the registration therefor, together with the goodwill of the business symbolized by the Trademark, along with the right to recover for damages and profits for past infringements thereof; and

WHEREAS, said affidavit under Section 8 was not timely accepted by the United States Patent & Trademark Office, and Quail Run Vintners Inc., applied on January 23, 1996 to re-register the Trademark.

WHEREAS, Quail Run Vintners Inc., General Partner of Quail Run Cellars and Vintners, located at 1500 Vintage Road, Zillah, Washington 98953 ("Assignor"), in its own capacity and as assignee of Quail Run Vintners at all times since at least as early as April 25, 1986, continuously until May 8, 1996, owned the Trademark and used it in commerce; and

WHEREAS, Covey Run Winery, Inc. located at 1500 Vintage Road, Zillah, Washington 98953 ("Assignee"), acquired from Assignor on May 8, 1996, for good and valuable consideration, receipt of which is hereby acknowledged, any and all rights that Assignor had in and to said trademark, any registrations thereof, and the pending application therefor, together with the goodwill of the business symbolized by the Trademark, along with the right to recover for damages and profits for past infringements thereof, and has continuously used the same in commerce at all times since said date; and

WHEREAS, the United States Patent & Trademark Office issued Registration No. 2,040,214 for the Trademark to Quail Run Vintners Inc. on February 25, 1997, which registration is the property of Covey Run Winery, Inc., pursuant to the aforesaid transaction,

NOW, THEREFORE, Assignor does hereby memorialize its assignment on May 8, 1996 unto Assignee all right, title and interest in and to the Trademark and the registration therefor for the United States and throughout the world, together with the goodwill of the business symbolized by the Trademark, along with the right to recover for damages and profits for past infringements thereof, and hereby assigns to Assignee the aforesaid Registration No. 2,040,214.

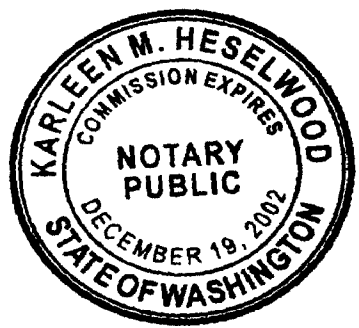
