TERMINATION OF INTEREST IN TRADEMARKS

This TERMINATION OF INTEREST IN TRADEMARKS is executed as of February ~~13~~, 2000 by THE BANK OF NOVA SCOTIA, in its capacity as Administrative Agent (the "Agent"), with reference to that certain Amended and Restated Credit Agreement, dated as of June 9, 1999 (the "Credit Agreement"), among The Titan Corporation (the "Borrower"), the various financial institutions from time to time parties thereto, the Agent. .

Pursuant to the Credit Agreement, each of The Titan Corporation, Linkabit Wireless, Inc., DBA Systems, Inc., Titan Scan Corp., Horizons Technology, Inc., Delfin Systems, VisiCom Laboratories, Inc., Atlantic Aerospace Electronics Corporation, Unidyne Corporation, and VisiCom Manufacturing Corporation (formerly known as Microlithics Corporation) (collectively, the "Owners") executed and delivered to the Agent a Trademark Security Agreement, each dated as of June 9, 1999, each of which was recorded with the United States Patent and Trademark Office (collectively, the "Agreements").

For good and valuable consideration, receipt of which is hereby acknowledged, the Agent hereby:

- (a) terminates each Agreement;
- (b) releases the liens and security interests granted to it in and on the trademark registrations referred to in each Agreement which are listed on Schedule 1 hereto (the "Property") and acknowledges, agrees and confirms that it has no right, title or interest in or to (or security interest in) the Property, and
- (c) to the extent the Agent shall be deemed to have any right, title or interest in the Property, retransfers and reassigns to the applicable Owner all of such right, title and interest.

This Termination of Interest in Trademarks shall be governed by the laws of the State of New York and shall relate solely to the Agreement and shall in no way be construed as relating to any other trademark interest in the Property which the Agent may have.


